Homelessness Policy & Advisory Role

Short Summary

The Cal ICH advisory committee discussed policy, practice, and integrating lived experience to combat homelessness.

Long Summary

The Cal ICH advisory committee convened to establish a foundational understanding of its work in addressing homelessness. The discussion emphasized the critical need for a clear statutory framework, the impact of federal policy shifts, and the importance of incorporating best practices and lived experiences into policy and service delivery. Members identified the committee's role as a vital voice for practical solutions to policymakers, aiming to ensure real progress and accountability in combating homelessness across California.

Advisory Committee's Role and Structure

- The committee's purpose is to provide expertise and create a foundational understanding of the work on homelessness for both the committee and the public.
- The committee is encouraged to act as a "megaphone" for best practices, particularly when political pressures make it difficult for state agencies to do so.
- Members may be asked to join Cal ICH in legislative presentations to share their expertise and stories.

Statutory Framework for Homelessness

- A key issue identified is the lack of a statutory framework in California that defines roles, responsibilities, and funding commitments for addressing homelessness.
- A proposed framework should include:
 - **Policy:** A clear statutory basis for the work.
 - Funding: A dedicated and ongoing commitment.
 - Accountability: Linking funding and responsibilities to specific outcomes.
- The current three-year action plan is seen as an opportunity to develop recommendations for codifying these responsibilities into law.

Federal Policy and State Response

- There is significant concern about a federal executive order on homelessness, viewed as potentially harmful and a threat to current housing projects and funding.
- The committee is urged to advise the state on a comprehensive response to changes in federal policy and potential funding cuts.
- Cal ICH is working with the Governor's and Attorney General's offices to assess the potential impacts on California's braided federal and state funding.

Committee Operations and Communication

- The committee meets quarterly in public meetings, as required by law, which prevents private meetings as a full body.
- To improve communication between meetings, Cal ICH will provide monthly updates to the committee.
- These updates will inform members of policy developments and offer opportunities for further engagement.

Lived Experience Integration

- A concern was raised about ensuring feedback from individuals with lived experience meaningfully impacts policy and recommendations.
- Cal ICH collaborates with its Lived Experience Advisory Board (LEAB) on various projects.
 - Examples include developing guidance on Housing First principles and creating materials for people experiencing unsheltered homelessness.
- Cal ICH is committed to demonstrating how this feedback is directly integrated into its work products.

Public Comments

 A commenter expressed hope that the committee would address the federal executive order to prevent the collapse of housing projects. A representative from Sonoma County's Behavioral Health Board urged the committee to integrate local behavioral health plans into the state's strategy to avoid service silos.

Next Steps

- The next advisory committee meeting is scheduled for November 5th, from 1:00 to 3:00 PM.
- Members will receive an onboarding packet with the committee charter to review before the next meeting.
- The next full Cal ICH council meeting will be on September 3rd at 1:00 PM.

Um, the- the components that I think are most valuable are about first having a statutory framework that addresses what we're trying to accomplish, um, who's doing work, and what the funding commitment is on a going forward basis. I know there's some politics around that. But, we... That doesn't exist. There's nothing in state law that says that we're to really do anything around homelessness. And I find that unacceptable, um, as someone that represents counties and

we struggle with it and we have our own challenges and folks can, can point those out, but it's true for other players in this as well. So that, that's, there's that statutory framework which has policy, funding, needs to have accountability. And then that's at, at that policy level and then there's a practice level that I think this group can be really valuable, um, in addressing which does touch on housing support and what that looks like. Emergency, interim transitional, permanent supporting where it's needed. Um, resource support in terms of folks just sustaining themselves. The services support which touches some of what counties are responsible for and others as well, health plans and, and community-based organizations and others. All that services support that needs to be put in place. Education and training so that some can actually be stable on a going forward basis. And then having the right data which I'm hoping we don't overly complicate. We keep it as focused as possible on what the outcomes are, um, and then have accountability linked to all of that. So that the dollars are aligned to the responsibilities, are aligned to the, um, accountability, are, is aligned to the outcomes and if any lever in that isn't working, like it all kind of falls apart, and we have the opportunity to really build.

Yeah, super helpful, Graham. Um, I just want to elaborate a little bit more for those of you who are not, um, who haven't been reading welfare institution codes or health and safety codes in your spare time. But, um, to Graham's point, um, and I think I, I touched on this briefly, but in, in the state law, um, we identify counties as being responsible for a certain set of services. So, those are mostly our safety net programs, right? So, counties are responsible for administering, um, cash assistance programs like CalWORKs. Uh, they operate general assistance or general relief, uh, programs for, for single adults. They are very clear on who does that and, and what they, uh, what they receive to, to accomplish those, those benefit, um, the administration of those benefits. There's no mention, there's no clarification of who, uh, locally is responsible for addressing their community's, um, homeless needs. And so I can abso- the, let me back up to the action plan. So, we have our, um, our, uh, progress report. That is, is going to be, um, our timeline for publication of that is in March of 2026. And that's going to be, you know, a year in reflection of what we've accomplished, how that, how the landscape of, of, um, funding has changed, whether it's state funding, we will have programs that have sunset in the time, you know, from the, the adoption of the plan to the time that we're writing this progress report, um, but also the, the changing landscape in federal policy. The culmination report for the three-year action plan is absolutely going to be that time, uh, to make those recommendations that are not tied to a specific program or to a, a specific program type. I can see a world in which this body redevelops the recommendation to say, uh, it would benefit the state of California to identify and clarify and codify, uh, rules and responsibilities to address homelessness in, in law. Um, so I, I do think there's opportunity, avenue to accomplish that recommendation or that, um, m- moving that work forward, Graham, I would say is in, in our, uh, in our updates to the action plan. Should also said, this is the first action plan that is, uh, is a three-year plan, which, uh gives us time to sort of assess, provide interim updates as opposed to what it, it had been traditionally was a one-year action plan. Um, so lots of opportunities to inform, um, uh, change through the lifespan of this, this particular plan, so.

Um, I think one of our more recent projects was, uh, around Housing First and so those principles and how exactly are we supposed to carry out Housing First in local communities, but also how do folks in local communities, uh, feel about, about helping its implementation. And so we were able to get feedback around, um, the ways that we think it should look like when you're implementing Housing First correctly, um, but also with a person center view and make sure that you are trauma-informed and not just giving care and services, but access to housing support networks. And so being able to show that experience around Housing First principles, um, was helpful. And so just how important for, um, for our Housing First, uh, policy specialist was coming into meetings, sharing the information and then sharing how, um, resources, materials, um, are incorporated or created based on that feedback.
