Homelessness Advocacy and Policy Challenges

Short Summary

A webinar on advocating for unhoused people amidst challenging federal policies and systemic issues.

Long Summary

The webinar addressed strategies for homelessness advocacy, focusing on emergency housing vouchers and countering federal actions weaponizing unhoused populations. Speakers discussed shifting the narrative, ensuring proper Housing First implementation with adequate funding, and broadening advocacy efforts. They emphasized the need for systemic change, coalition building, and providing resources to communities preparing for potential federal interventions, highlighting the collective effort required.

Emergency Housing Vouchers (EHVs)

- A primary concern is that EHVs will expire next year, forcing recipients onto long waitlists for Housing Choice Vouchers.
- Advocacy should humanize the issue, highlighting that EHVs help vulnerable individuals, including victims of domestic violence and the long-term homeless.
- The most effective solution is to secure funding for all current EHVs through new appropriations, preventing displacement of others on voucher waitlists.

Federal Strategy on Homelessness

- The White House is using Washington D.C. as a test case for new policies, weaponizing unhoused individuals as political pawns.
- The strategy involves deploying the National Guard and federal agents to displace homeless populations.
- The administration has identified Los Angeles, Oakland, Philadelphia, New York, Chicago, and Baltimore as the next cities to replicate this approach.

Community Preparation and National Support

- The National Homelessness Law Center is coordinating with targeted cities to share lessons learned from responses in D.C. and Los Angeles.
- Resources being shared include disaster planning materials and strategies from the initial COVID-19 response.
- The Alliance is developing guidance for communities that may be impacted by federal actions and executive orders.
- Communities are advised to proactively engage with local administrations.

Shifting the Narrative on Homelessness

- A significant challenge is regaining control of the public narrative at local, state, and federal levels.
- Strategies are being developed with partners like Invisible People and Housing Narrative Lab to communicate more effectively with the public and lawmakers.
- Advocates are encouraged to use local data and personal stories, focusing on successes and effective solutions, not just challenges.

Housing First Model and Resource Needs

- The "Housing First" model is effective but is under-resourced.
- Successful implementation requires robust investment in:
 - Adequate funding to support the workforce.
 - A sufficient number of case managers to ensure manageable caseloads.
 - Comprehensive wraparound services for individuals once they are housed.

Future Funding and Grant Concerns

- There is uncertainty regarding future funding, especially with HUD potentially re-competing the Fiscal Year '25 NOFO
- The administration may shift priorities towards service and sobriety mandates and away from Housing First.
- The Alliance is preparing to provide guidance to help communities sustain effective approaches and navigate new federal requirements.

Broadening Local Advocacy Efforts

- Local providers are encouraged to adopt a two-pronged advocacy strategy:
 - Build relationships with state and federal representatives to educate them.
 - Form broader coalitions with organizations from other sectors like LGBTQ, immigrant, and racial justice rights to build collective power.
- Advocacy can be done through various means, including emails, calls, inviting lawmakers to site visits, or holding town halls.

Call for Community Feedback and Action

- The Alliance asked attendees for feedback on their needs and local preparations.
- Key needs identified include state-specific guidance on executive orders, advocacy for mental health resources, and hands-on advocacy training.
- Local community preparations include relying on supportive local leaders who may use legal challenges and collaborating with immigrant rights groups on rapid response tactics.
- Newcomers to advocacy are encouraged to participate in the Virtual Capitol Hill Day as an entry point.

Like you said, there's so much going on, um, but you always have to keep the focus on who the EHVs are actually helping. These are people that are harassed to house, people who are victims of domestic violence, um, you know, along those lines. And-

You know, people are-- who have just been on the streets for a very long time here, for the first time are finally able to access housing. Um, the good news is, I-- to sort of go to your first part of your question, the PHAs are aware of this, and they are still working on strategies to, um, help get these folks into housing vouchers soon. However, that is not an ideal situation as, um, you know, obviously if you've just taken away Housing Choice Voucher for someone who's got an EHV, that means the person who's been on the waiting list will have to wait even longer. So the best route to go is to ensure that all the EHVs that are currently out there are funded through our new appropriations, which John had mentioned earlier.

And so there can be a lot of frustration. I know I had a caseload of over 40 people, which is not that ideal for one person. Housing First does work, you just need the, the investment to be able to implement it correctly. You need enough case managers, you need enough wraparound services so that when someone is placed in housing, they're not just given a key and, you know, uh, a wish of good luck. But they actually have someone there helping them through the process and the system. So it's not that Housing First doesn't work, it's just in order for it to work, you need robust resources and funding to be able for it to, to happen the way it should.

You know, as you know very well, we are in a, in a, uh, unprecedented, uh, political situation, uh, and some of, if not all of that, is driving the policies. So we have-

So, so r-reach out to your representatives, build relationship with those offices, but also reach out to other folks who are on, on the same boat who also wanna, uh, build power and add pressure to, uh, to those legislatures.

... single day, but it feels like it's a boat that is flooding and no matter how much we bail of the boat, more water keeps coming in. So at what point do we, using the analogy, kind of turn off the faucet? And that's kind of the framing that we've been trying to use for lawmakers. You know, the data shows that, you know, providers are rehousing hundreds and hundreds of thousands of people every single year, but even more people are falling into homelessness and experiencing it, many for the first time, in a given year. Um, the data that HUD has shows that about 19,000 people every single week, um, enter into homelessness. So the systems are working, but we're swimming in a much larger, um, issue of all these systemic-

... policy barriers, then the homelessness response system is tasked with bailing out all those other different systems. So it's really hard to kind of thread that needle. You know, what we're doing works but we need a lot more help, not just in terms of, you know, additional housing resources but really fixing a lot of these broken feeder systems, whether or not that's the homelessness to jail and jail to homelessness pipeline, whether or not that's reforming foster care in the child welfare system to make sure that no one ever experiences homelessness exiting that system. So there's a lot of work that we need to do in terms of educating lawmakers about all the other systemic failures that are hindrances to our work. We acknowledge that the country is not a monolith, where folks see on national, uh, laws and executive orders that have very different but very real implications at the state and the local levels so we want to make sure we can tailor that, and also make sure that they tailor those advocacy strategies. That's something that we've especially seen in the space of pushing back against these different punitive...

... playing defense, and making sure that we stand ready, um, if there's a funding freeze, if there's a slowdown, anything that, you know, impacts our work, how do we have the tools in place to make sure that we are still able to serve people, um, despite those uncertainties? So that is also something that we're very much focused on in terms of guidance.

There's various ways to, to advocate, whatever makes you feel comfortable. And if you do, um, work for, uh, a government agency or another, um, agency, you can always advocate, um, on your own personal time as a concerned citizen if you're concerned about doing so on, on work time. And advocacy is a wonderful way to get to know your community members, especially persons with, um, with experience to know firsthand, uh, what it's like to experience going through the system and, and all the barriers to accessing housing. ... trying to build relationships with local state and federal lawmakers so that maybe they see you as a trusted partner and they may come to you for advice on policies and legislation that they might be willing to introduce or to determine, you know, what stance they should take. Um, so I just wanted to put that out there that I strongly feel that despite all the things that are going on right now, um, that there is, there is hope through, through advocating and we still have a chance to, to influence what happens.

Thank you so much, Samantha. Um, we're gonna switch over to the next question that we're seeing here, which is, uh, we were asking folks what steps are you taking in your community to prepare if the administration replicates their approach to attacking D.C.'s unhoused populations? Something I saw here is someone wrote, "Most of our local leaders do not support the approach and likely won't comply, and also will likely use the courts." I want to shout out to our friends in Connecticut, if anyone from Connecticut is on this call. Uh, they were able to mobilize and get a large swath of their state leadership, including, uh, the governor, to come out against the executive order that the White House issued a couple of months ago, that would be really harmful for our populations. And come out and denounce that order and say, "That is not something that we're going to be focusing on in our community." So, it was a fantastic opportunity to see an example of engaging leadership, um, at the local and the state levels, um, to be able to kind of speak out and elevate these issues. Something else that I'm seeing here, a couple of different comments are kind of tying homelessness response to kind of the crisis also of the targeting of undocumented folks in our communities and other groups of immigrants. And so, I saw, you know, for example, collaborating with groups that are reporting ICE and kind of sharing lessons in terms of, you know, rapid response and monitoring for federal agents on our streets and trying to keep vulnerable neighbors safe. So, there's some great thinking here. Appreciate all the forward thinking that folks are doing. We're trying to do our best to be able to kind of, again, share lessons and share any guidance we have. But we also know that sometimes this is a, this is a local approach, so we know it's not one size fits all. Uh, before we wrap up in a couple minutes, any other, uh, reflections from policy team members from what they're seeing in the chat here?

This is an all hands on deck. Like, we are all one big community at this point. Uh, you know, I, I hope that you all see us as a resource. We are very available. We'll make ourselves, ourselves available. Um, but, you know, I, I see a, a, a ... I, I can't think of what these little squares are called, but, um, I see one that says, "I don't know what our community is planning." And like that, that makes me sad, both that, um, maybe those things aren't, aren't being communicated, but, you know, maybe something that we can help with is making those connections in your community. Uh, and also thinking about using this, uh, Capitol Hill Day as an opportunity to make those connections. So not just folks from with, in your community, but also across the state, so that you all can be thinking about this, uh, again, beyond just your CoC and the, and the place in which you're living. But how can we support each other across communities, um, and how can we support you in that work?
